

SUPERINTENDENT'S/PRINCIPAL'S CONTRACT

This agreement, made and entered into this 21st day of May 2007, between Barbara Meinershagen, a legally qualified public school teacher, of the first part, and the Board of Education of the CENTERVILLE R-1 SCHOOL, County of REYNOLDS, State of MISSOURI, of the second part.


WITNESSETH, that Barbara Meinershagen agrees to perform all duties and adhere to and administrate all present future board policy within the CENTERVILLE R-1 SCHOOL DISTRICT, for a term of TWO (2) years, beginning 1st of July 2007, for which services properly issue warrants in favor of the first part upon the treasurer of said district in accordance with the following terms:


- (A) The annual salary for the first year beginning July 1, 2007 shall be \$45,000.00 and shall be paid monthly in twelve (12) installments in accordance with the Board Policy.
- (B) The annual salary for the second year beginning (N/A) is negotiable and shall be no less than \$(N/A) and shall be paid monthly in twelve (12) installments in accordance with the Board Policy.
- (C) The termination date of the existing contract may at the end of any contract year be extended if agreeable to both parties, but at no time shall the remainder of the contract together with any extension exceed three (3) years.
- (D) Should the Superintendent/Principle be unable to perform any or all of his duties by reason of illness, accident or other cause beyond his control and said disability exists for a period of more than N/A during the school year, the Board of Education may in its discretion make a proportionate deduction from the salary stipulated, and if such disability is permanent, irreparable or such nature as to make the performance of his/her duties impossible, the Board of Education may, at its option, terminate this agreement, whereupon the respective duties, rights and obligations hereof shall terminate.
- (E) The Board of Education shall provide the Superintendent/Principal with transportation cost of .42 cents (forty-two cents) per mile when using his/her own vehicle in the performance of his/her official duties during his/her employment under this contract.
- (F) The Board of Education shall devote a portion or all of one meeting, at least annually, to a discussion with the Superintendent/Principal of an evaluation of his/her performance.
- (G) The Superintendent/Principal shall receive ten (10) days vacation annually exclusive of legal holidays and shall be entitled to three (3) days of personal leave and seven (7) days of sick leave annually. Vacation shall be taken during the contract year in which it is earned and shall not be cumulative.

- (E) Except as provided herein, the Superintendent/Principal shall be entitled to any or all fringe benefits provided by the Board of professional employees.
- (I) The Superintendent/Principal shall attend appropriate professional meetings at the local, state, and national level, the expenses of said attendance to be incurred by and approved by the Board of the district.
